### **EXTENSION OF THE CLUB'S ENHANCED CREW PRE-EMPLOYMENT MEDICAL EXAMINATION (PEME) SCHEME TO INDIA**

The Club's Enhanced Crew Pre-Employment Medical Examination (PEME) Scheme was initially established in the Philippines (Circular L.086 ) and subsequently extended to Ukraine and Russia (Circular L.107) in an on-going loss prevention effort to reduce the risk of unnecessary crew claims arising from pre-existing medical conditions and/or health risks.

Following continuing collection and analysis of crew claims data, it has been decided to expand the scheme further to include India. On the advice and recommendations of the Managers' independent UK-based medical consultants, Medical Rescue International (MRI), clinics have been selected, examination standards compiled and costs agreed.

As for the Philippines, Russia and Ukraine, the examinations are tailored to three age groups - under 30 years of age, 31 to 45, and 46 and over - and the medical examination guidelines are essentially the same as apply in the Philippines. The Managers fully appreciate that as with the other countries in which the scheme operates, many Members may already have arrangements in place in relation to PEMEs for recruits from India. The Club's PEME scheme is not compulsory and neither seeks to interfere with any of those arrangements nor to limit Members' choice of PEME clinics.

However, for the reasons outlined in Circular L.086 and Risk Alert 29, the Managers hope that Members will recognise the benefits that can be derived from the use of the Club's enhanced PEME scheme and the accredited PEME Clinics. The Managers therefore strongly recommend that the Clinics selected for the scheme are used to conduct Steamship Mutual PEMEs in the Philippines, Russia, Ukraine and India as far as possible in order to maximise the potential benefits for both Members and the Club.
