^ With effect from 15 October 2020, 0000 hours, all travellers entering Singapore who have a travel history in the past 14 days to Sabah will be required to serve a 14-day SHN at dedicated SHN facilities. This also applies to <u>returning</u> Singapore-based travellers under the Reciprocal Green Lane (RGL), as well as Malaysian citizens and PRs entering Singapore under the Periodic Commuting Arrangement.

<p><b>@</b> Travellers from these countries/places may opt out of dedicated SHN facilities and serve their 14-day SHN at their place of residence, if they fulfil the following criteria:</p> <ul style="list-style-type: none"> <li>Travelled to no other country than these countries/places, in the last consecutive 14 days prior to entry; and</li> <li>Are occupying their place of residence (i.e. residential address) alone, or only with household members who are also persons serving SHN with the same travel history and duration of SHN.</li> </ul> <p>Applications must be made at least three (3) days prior to arrival. To apply for opt out, Singapore citizens (SC) and permanent residents (PRs) should click on the link <a href="#">here</a>.</p> <p>For Non-SCs/PRs, the request to opt out should be indicated when seeking entry approval into Singapore.</p> <p>The list of countries/regions eligible for opt-out of dedicated SHN facilities will be updated from time to time depending on the public health risk assessment. <u>Travellers must be prepared that any prior approvals given for opt-out from dedicated SHN facilities may be revoked</u>, and the prevailing border measures upon entry will apply, including stay in SHN Dedicated Facility (SDF) and payment, where applicable.</p> <p><b>Note:</b> Travellers from Estonia and Norway previously granted approval but arriving from 8 Nov, 2359hrs will serve their SHN at SDFs.</p>

**Chargeable Cost**

The cost incurred for the COVID-19 swab test is chargeable for all travellers.

The cost incurred for the SDF is chargeable for all travellers, except Singapore citizens or permanent residents who have left Singapore before 27 March 2020 and return to Singapore on/ before 31 December 2020.
