Meeting of the Chairman, Chittagong Port Authority held at 11.00 a.m. with all Stakeholders for decision about continuation 24 hours x 7 days Operational activities of CPA during Lockdown period

A meeting of the Chittagong Port Authority was held at 11.00 a.m. on Tuesday, 29 June 2021 at Conference Room of CPA to discuss about important points related with continuation of 24 hours x 7 days operational activities during Lockdown period declared by the Government as preventive measure from COVID-19 Pandemic. The meeting was presided over by Rear Admiral Mohammad Shahjahan, NPP, BCGMS, ndc, psc, Chairman, Chittagong Port Authority. All Members including all high officials of CPA were present in the meeting.

In the meeting, Joint Commissioner of Customs, Assistant Commissioner of Police (Traffic), Port, Representatives of Banks, BSAA, BCSA, BGMEA, BAFFA, C&F Agents' Association, Berth/Ship Handling/Terminal Operators' Owners' Association and representative of other stakeholders were present.

Chairman/CPA thanked all for their attendance. Upon detailed discussion on opinion of all, following decisions have been taken for continuation of 24 hours x 7 days operational activities of CPA during Lockdown period:

Decisions:

- Operational work of CPA will continue 24 hours x 7 days
- Banks at Port and Agrabad Area will remain open
- Custom House will remain open 24 hours x 7 days
- Mr. Md. Mizanur Rahman, Assistant Commissioner of Police (Traffic), Port will communicate these decisions to all Law Enforcing Agencies
- Representatives of all Port Users will carry following documents with them during performance of their activities:
 - (i) NID Card (Photocopy)
 - (ii) ID Card issued by Employer Company/Firm
 - (iii) Jetty Entry Pass (if any) issued by Chittagong Port Authority
 - (iv) Bangladesh Shipping Agents' Association's letter No. BSAA/144/2021/159 dated 27-06-2021 to all concerned
- Mr. Md. Mizanur Rahman, Assistant Commissioner of Police (Traffic), Port has confirmed in the meeting to contact him at Cell Nos. **01711-371791/01320-050557** if anybody faces any problem
- Shipping Agents will contact Bangladesh Shipping Agents' Association if anybody faces any problem
