### DGS Circular No. 15 of 2021

### Sub.: <u>Addendum-II to DGS Circular No. 9 of 2021- Corona virus</u> (COVID-19) -arrangement for vaccination of seafarers-reg.

1. Whereas para 7 of DGS Circular No. 9 of 2021 dated 23.04.2021 has advised the following categories of Indian seafarers to utilize the vaccination facility at Mumbai Port Trust Hospital on production of CDC or SID,

- a) Seafarers who are of 45 years of age or above; or
- b) Seafarers who are less than 45 years but have to sign-on a vessel after 60 days. An online certificate to this effect to be issued by the Directorate General of Shipping;
- c) Seafarers above 18 years of age and below 45 years can use this facility after 1<sup>st</sup> of May, 2021.

2. Whereas the details of the arrangements made by Mumbai Port Trust, Kolkata Port Trust & Cochin Port Trust for vaccination of essential workers is mentioned in the DGS Circular No. 9 & 10 of 2021.

3. Whereas detailed "Standard Operating Procedure" (SOP) to enable the seafarer/RPSL/Shipping company to register and generate the online Sign- on Certificate for Covid-19 Vaccination is mentioned in the Annexure to the DGS Circular No. 10 of 2021 dated 28.04.2021.

4. In order to facilitate Covid- 19 vaccination at other ports also and to roll out vaccination drive for seafarers, arrangements have been made by the respective Port Trusts at their Hospitals. The details of the Hospitals and the Nodal Officers is mentioned in **Annexure** to this Circular.

5. Whereas some of the Private Hospitals/ Covid Vaccination Centers have shown their readiness for providing Covid vaccination to the Seafarers with their terms and conditions. The detail of vaccination facility available at Private Hospitals/Centers is also mentioned in **Annexure** to this Circular.

6. It is impressed that the vaccination drive will be subject to the availability of the vaccines at the Hospitals/Centers and would be regulated in accordance with the SoP.

7. Further, it is reiterated that Seafarer/RPSL/Shipping Company are required to register on the DGS website for the vaccination as per the SOP mentioned in DGS Circular No 10 of 2021, they are required to get themselves registered on the <u>Co-WIN Portal</u> also and schedule his/ her vaccination appointment at <u>https://www.cowin.gov.in/home</u> with the respective Port Trust Hospital/Centres.

8. This issues with approval of Director General of Shipping & Additional Secretary to the Govt. of India and Chairpersons of respective Port Trust.
