# Iran (nuclear proliferation)

# Council Implementing Regulation (EU) No 1245/2011

This notification is issued in respect of the restrictive measures directed by the Council of the European Union against Iran.

- With the publication of Council Implementing Regulation (EU) No 1245/2011 of 1 December 2011 ["Regulation 1245/2011"] in the Official Journal of the European Union (O.J. L319, 02.12.2011, P.11) on 2 December 2011, the Council has amended Annex VIII to Council Regulation (EU) No 961/2010 ["the 2010 Regulation"], with effect from 2 December 2011.
- 2. Annex VIII to the 2010 Regulation lists persons, entities and bodies identified by the Council under Article 16(2) of that Regulation as subject to the financial sanctions imposed by that Regulation.
- 3. The amendments to Annex VIII to the 2010 Regulation take the form of the addition of 37 individuals and 143 entities and updated the identifying information in relation to a number of existing entries.
- 4. The individuals and entities added to Annex VIII are therefore subject to the asset freeze imposed by the 2010 Regulation.
- 5. Details of the additions are set out in the Annex to this notification.
- 6. The Treasury's Consolidated List of persons subject to financial sanctions in effect in the UK, which is maintained on the Treasury website, has been updated to reflect the additions.
- 7. It should be noted that the Annex to this notification and the Consolidated List does not include all the background information provided by the Council. Reporting requirements

8. Relevant institutions and other persons are requested to check whether they maintain any

accounts or otherwise hold any funds or economic resources for the persons set out in the

Annex to this notification whose details have been added to or amended in Annex VIII to the

2010 Regulation and, if so, they must freeze such accounts or other funds and, unless

licensed by the Treasury, refrain from making available funds and/or economic resources to

such persons.

9. Relevant institutions must report their findings to the Treasury, together with any additional

information that would facilitate compliance with the 2010 Regulation.

10. Where a relevant institution has <u>already reported</u> details of accounts, other funds or

economic resources held frozen for any of the persons in Annex II, they are not required to

report these details again.
