

# **Financial Sanctions Notice**

13.05.2014

# **Ukraine (Sovereignty and Territorial Integrity)**

#### Introduction

1. Council Regulation (EU) No. 269/2014, the Regulation imposing financial sanctions in respect of Ukraine (Sovereignty and Territorial Integrity), has been amended so that an asset freeze now applies to the persons listed in the annex to this Notice.

# Notice summary (Full details are provided in the annex to this Notice).

2. 15 entries (13 individuals and 2 entities) have been <u>added</u> to the consolidated list and are now subject to an asset freeze. See the annex to this Notice for details.

# What you must do

# 3. You must:

- i. check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice.
- ii. freeze such accounts, and other funds or economic resources.
- iii. refrain from dealing with such accounts, funds or economic resources or making them available to such persons unless licensed by the Treasury.
- iv. report any findings to the Treasury, together with any additional information that would facilitate compliance with Regulation 269/2014.

- v. provide any information concerning the frozen assets of designated persons that the Treasury may request. Information reported to the Treasury may be passed on to other regulatory authorities or law enforcement.
- 4. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

# Legislative details

- 5. On 12 May 2014 Council Implementing Regulation (EU) No. 477/2014 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 137, 12.5.2014, p.3) by the Council of the European Union.
- 6. The Amending Regulation amended Annex I to Council Regulation (EU) No. 269/2014, with effect from 12 May 2014.

# Other changes to Regulation 269/2014

10. In addition the Council has broadened the legal basis for EU restrictive measures through Council Regulation (EU) 476/2014. It added the possibility of targeting persons associated with actions and policies undermining stability or security in Ukraine as well as with obstructing the work of international organisations in the country, and entities linked to such persons. The Council also provided a legal basis for asset freezes on

entities in Crimea and Sevastopol which have been confiscated, or entities which have benefited from such confiscation.
