Ivory Coast

Council Implementing Regulation (EU) No 113/2012

This notice is issued in respect of the restrictive measures directed against certain persons relating to the Ivory Coast.

- 1. With the publication of Council Implementing Regulation (EU) No 113/2012 of 10 February 2012 in the Official Journal of the European Union (O.J. L38, 11.2.2012, p.1) on 11 February 2012, the Council of the European Union has removed 30 individuals from Annex IA to Council Regulation (EC) No 560/2005 ["the 2005 Regulation"], with effect from 11 February 2012.
- 2. Annex IA to the 2005 Regulation lists persons and entities covered by the freezing of funds and economic resources imposed under Article 2 of that Regulation.
- 3. The individuals removed from Annex IA are therefore no longer subject to the asset freeze imposed under Article 2 of the 2005 Regulation.
- 4. The Treasury's Consolidated List of persons subject to financial sanctions in effect in the UK which is maintained on the Treasury website has been updated to reflect the deletions.
- 5. Details of the individuals removed are set out in the Annex to this notice.
