

Financial Sanctions Notification

Ivory Coast

Council Implementing Regulation (EU) No 623/2011

This notification is issued in respect of the restrictive measures directed by the European Union against certain persons and entities in view of the situation in the Ivory Coast.

- With the publication of Council Implementing Regulation (EU) No 623/2011 of 27 June 2011 in the Official Journal of the European Union (O.J. L168, 28.6.2011, P.2) on 28 June 2011, the Council of the European Union has removed three entities from Annex IA to Council Regulation (EC) No 560/2005 ("the 2005 Regulation"), with effect from 28 June 2011.
- 2. Annex IA to the 2005 Regulation lists persons and entities covered by the freezing of funds and economic resources imposed under Article 2 of that Regulation.
- 3. The entities removed from Annex IA are therefore no longer subject to the asset freeze imposed under Article 2 of the 2005 Regulation. Details of the entities removed are set out in the Annex to this notification.
- 4. The Treasury's Consolidated List of persons subject to financial sanctions in effect in the UK which is maintained on the Treasury website has been updated to reflect the deletions.
